WHEREAS the Petitioner above named through their Advocate Sri KUNUKU RAJA SEKHAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Certiorari (i) to call for the records relating to the proceedings in R.C.No.1051/2026/D4 (3001/2017/SDT-I KRRC), dated 19.05.2026, passed by the 3<sup>rd</sup> Respondent-Joint Collector & Revisional Authority, Vizianagaram District, and to examine the legality, validity and propriety thereof and declare the action of the 3<sup>rd</sup>

Respondent in setting aside the proceedings of the 4<sup>th</sup> Respondent vide Rc.No. 187/2016/A, dated 07.06.2016, and directing mutation of the subject lands admeasuring Ac.8.56 cents in Sy.Nos.31/1, 31/2, 32/1 and 32/2 of Pedamanapuram Village, Dattirajeru Mandal, Vizianagaram District, in favour of the legal heirs of the MDR Pattadar, despite recording findings that serious disputes relating to title, possession and succession exist between the parties and that the allegations of manipulation of revenue records were not established, as illegal, arbitrary, self contradictory, without jurisdiction, violative of the principles of natural justice and Articles 14, 21 and 300-A of the Constitution of India (ii) consequently to set aside the proceedings of the 3rd Respondent in R.C.No.1051/2026/D4 (3001/2017/SDT-I KRRC), dated 19.05.2026 (iii) consequently to restore and confirm the proceedings of the 4th Respondent-Tahsildar, Dattirajeru Mandal, in Rc.No. 187/2016/A, dated 07.06.2016 and (iv) direct the respondents not to alter, modify or effect any mutation or consequential changes in the revenue records relating to the subject lands except in accordance with due process of law;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri KUNUKU RAJA SEKHAR Advocate for the Petitioner, GP for Revenue Department for R1 to R4 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
