Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass orders in exercise of extraordinary powers under Article 226 of the Constitution of India particularly one in the nature of writ of mandamus declaring the impugned Memo No. 3/ Holagunda PS/2025 dt. 4.6.2026 of the 2nd respondent as arbitrary, illegal, violative of Article 14, 19 and 21 and 300 A

of the Constitution of India the orders in WP No. 25545/2022 dt. 19.9.2025, and consequently set aside the same and direct the respondents not to interfere with the possession of the land in an 12.73 cents already allotted to him in EP 14/2015 and his share in the remaining land of 12.74 cents in RS No.s 386 A, 383 A1 A, and 380 B (25 Acres).

IA NO: 1 OF 2026

Petition under Section 151 of CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend Memo No.3/ Holagunda PS/2025 dt. 4.6.202 and consequently directions to the respondents not to interfere with the petitioners rightful possession and enjoyment of the joint family land in Rs. No.s RS No.s 386 A, 383 A1 A, and 380 B in total extent of 25 Acres, pending disposal of WP 15369 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Kasa Jaganmohan Reddy, Advocate for the Petitioner and of GP for Revenue for Respondent Nos. 1, 3 & 6 and of GP for Revenue for Respondent No.2, the Court made the following

ORDER:

“Learned Government Pleader for Home takes notice on behalf of respondent Nos.1, 3 & 6.

Learned Government Pleader for Revenue takes notice on behalf of respondent No.2.

Learned counsel for the writ petitioner is permitted to take out notice to respondent Nos.4 & 5 through Registered Post with Acknowledgment Due and file proof of service in the Registry.

In the meanwhile, Respondent No.3 may take steps for preventing breach of peace between the parties and shall serve copies of order, if any passed, on the petitioner before the next date of hearing.

For filing counter-affidavit, list the matter on 16.06.2026.”
