WHEREAS the Petitioner above named through his/her Advocate K SRINIVAS presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order, or Direction, more particularly one in the nature of a WRIT OF MANDAMUS,

declaring the action of the Respondents, more particularly the Respondents No. 2 to 5 in interfering with the peaceful possession and enjoyment of the petitioner land bearing Sy. No. 232, admeasuring Ac. 0.17 cents and Sy. No. 232, admeasuring Ac. 0.76 cents, situated at Palasamudram Village, Gorantia Mandal, Sri Satya Sai District, as illegal, arbitrary, and violative of the fundamental rights guaranteed under Articles 14,19, and 300-A of the Constitution of India and consequently direct the respondents not to interfere with the peaceful possession and enjoyment of the petitioner over the said property, except in accordance with due process of law and pass

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of Sri K SRINIVAS Advocate for the Petitioner, GP FOR REVENUE Advocate for Respondents no 1 to 3, STANDING COUNSEL FOR NHAI Advocate for Respondents no 4 to 6, GP FOR R & B Advocate for Respondent no 7, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
