Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction more particularly one in the nature of Writ of Mandamus declaring (a) the action of 3rd respondent in not taking action against the illegal Kalyana Mandapam constructed by the 7th respondent without obtaining permission and, (b) the action of respondents 3 to 6, in giving water connection from the borewell in petitioners land to the Kalyana Mandapam constructed by the 7th respondent and, (c) the action of respondents in trying to dispossess the petitioners from the land admeasuring Ac.2.00 Cents in Sy.No.4P of Ayyavaripalem Revenue, V.V.Palem Mandal, Prakasam District, without issuing any notice, without following due process of law, as illegal, arbitrary, violative of Principles of Natural Justice, Articles 14, 21 and 300-A Constitution of India, Consequently direct 3rd respondent to take appropriate action against the unauthorized and illegal kalyanamandapam constructed by the 7th respondent, by disconnecting the water supply from the borewell and further to direct the respondents not to dispossess the petitioners from the land admeasuring Ac.2.00 Cents in Sy.No 4P of Ayyavaripalem Revenue, V.V.Palem Mandal, Prakasam District.
