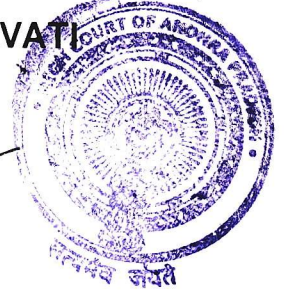

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased may be pleased to issue an appropriate writ, order, or direction, particularly in the nature of a writ of Mandamus, declaring the action of the 4th respondent in issuing proceedings vide 159579/A9/2023 dated 22.06.2024 as illegal, arbitrary colourable exercise of the official power, and violation of the G.O.Ms.No.343, (Panchayatraj (SAM.I) Department), dated 10.04.1978 and G.O.Ms.No.776, dated 31.12.1990 of the Food and Agriculture (Fish-II) Department and consequently set aside this impugned proceedings vide 159579/A9/2023 dated 22.06.2024; ✓

In view of the nature of the relief sought in this writ petition, this Court feels that the Commissioner for Fisheries is the proper and necessary party to the writ petition and accordingly, he is suo motu impleaded as respondent no.29 in the writ petition.

Registry is directed to make necessary amendments.

This court further deems it necessary to direct the Commissioner for Fisheries and the Commissioner for Panchayat Raj & Rural Development, to form a two-men committee comprising a District Fisheries Officer and Divisional Panchayat Officer to enquire as to whether all the members of the petitioner's society are Fishermen or not. The two-men committee shall issue notice to the society well in advance so as to facilitate presence of all the members at the time of their proposed visit. The two-men committee shall file a report by the date of next adjournment.
