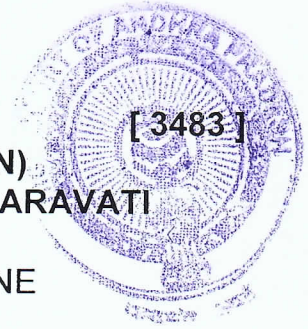

WHEREAS the Petitioner above named through his Advocate Sri CH SUJATHA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass a Writ, Order, or Direction, more particularly one in the nature of Mandamus declaring the inaction of the respondents in not considering my application Dated 29.08.2017, till 2023 post me as TGT Science in AP Model School, Hamasavaram, Tuni Mandal, Kakinada District Subsequent to my request/ application Dated 29.08.2017 for interstate transfer on Spouse ground and also the inaction of the respondents in posting a TGT Science post in 2023 ignoring my ease, and further notifying and advertising in Website the post of TGT Science in the said School Zone - II as vacant in the Notification/Advertisement Dated 19-04-2025 and 20-04-2025 for Mega DSC 2025 as being illegal, arbitrary, malafide, unconstitutional and in violation of Articles, 14, 16, 19 and 21 of the Constitution of India and consequently direct the respondents to post me in AP Model School, Hamasavaram, Tuni Mandal, Kakinada District (APMS, Zone -11) and further de - notify the post of TGT Science in the said school (i.e. TGT Science, Zone - II) as not a clear vacancy as read in the Advertisement in Website Dated 20-04- 2025 published by respondents especially 1,3 and 4 and there of and pass any other order or orders as it deems fit and proper in the facts and circumstances of the case in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri CH SUJATHA Advocate for the Petitioner and of GP FOR SCHOOL EDUCATION for Respondents 1, 4 and 5 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
