For the reasons mentioned in the accompanying affidavit filed in support of the petition the order dated 28.04.2026 in Crl.M.P.No.92 of 2026 in Crl.A.No.70 of 2026 on the file of the learned IV Additional Sessions Judge, Tanuku, is stayed, subject to petitioner paying 10% cheque amount within a period of four weeks from this date.

On failure to deposit 10% of the cheque amount within the above stipulated period, the learned Trial Court is at liberty to proceed in accordance with law for recovery of the said amount.

On such deposit, respondent No.2 is at liberty to withdraw the same by producing sufficient sureties to the satisfaction of the learned Trial Court concerned.
