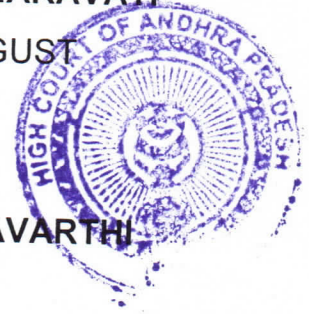

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of all further proceedings including the appearance of the Petitioner in CC.No.189/2019 offences under Section 323, 341, 506 r/w 34 of IPC., on the file of the Hon'ble Judicial Magistrate of First Class at Palamaner, Chittoor District, pending disposal of CRLP No. 5433 of 2023, on the file of the High Court.

Issue notice to respondent No.2.

Learned counsel for the petitioners is permitted to take out personal notice to respondent No.2 through registered post with acknowledgment due and file proof of service into the Registry within a period of six (06) weeks.

Considering the facts and circumstances submitted by the learned counsel for the petitioners, *"the presence of the petitioner Nos.2 and 3 herein/A2 and A3 in the proceedings before the learned Judicial Magistrate of First Class, Palamaner, Chittoor District, in C.C.No.189 of 2019 is dispensed with, except on the dates as directed by the learned Magistrate"*.
