WHEREAS the Petitioner has presented under Sections 10 to 12 of the
Contempt of Courts Act 1971, above case through his counsel Smt. Kavitha
Gottipati, praying that this Hon'ble High Court may be pleased to punish the
respondents herein for willfully and deliberately disobeying the orders in
W.P.No.13568 of 2019, dated 12.10.2018;

WHEREAS the said case coming on for orders as to admission on this
day and whereas the High Court, upon perusing the affidavit filed therein and
upon hearing the arguments of Smt. Kavitha Gottipati, Advocate for the

Petitioner, directed issuance of Notice to the respondent Nos. 3 and 4, to show cause as to why in the circumstances stated in the affidavit filed in support thereof, the said case should not be admitted.

The Court further made the following ORDER:

“A learned Single Judge of the erstwhile High Court of Andhra Pradesh, in its order, dated 12.10.2018, in W.P.No.13568 of 2010, had directed the respondents to consider the case of the petitioner for regularization with retrospective effect, in terms of G.O.Ms.No.328, dated 15.10.1997 and G.O.Ms.No.56, dated 05.12.2014.

The petitioner, aggrieved by non-consideration of his case, approached this Court, by way of the present Contempt Case.

The respondents have filed a counter affidavit, contending that the case of the petitioner had been considered and rejected, by an order, dated 13.06.2020. A perusal of the order does not show any consideration except rejection of the request of the petitioner. Such a bald refusal cannot be treated to be compliance of the orders of the Court.

It appears that the respondents shown in the Contempt Case are transferred out from their positions and Sri Kona Sashidhar and Sri Narayan Bharath Gupta, are now the Principal Secretary, Higher Education and Director of Collegiate Education respectively. As their presence is necessary for proper implementation of the orders of this Court, they are suo moto impleaded as respondents 3 & 4 in the Contempt Case.

Registry is directed to issue notice to respondents 3 & 4.
