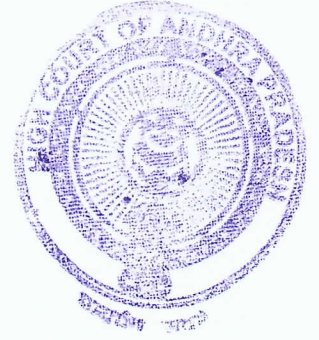

Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may

be pleased to issue writ of mandamus or any other appropriate writ or direction declaring the action of the 1st respondent in issuing G.O.Ms.No.33, dt.12-6-2025 withdrawing the orders issued for naming of bridge constructed in between Turpupalem and G.Paliepalem Gram Panchayats on Sankaraguptam major drain as "Keertiseshulu Adabala Shavukaru Narasimhaswamy Varadhi without mentioning any reasons and without call for public opinion is illegal, arbitrary and violative of principals of natural justice and consequently the setaside the same.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the impugned G.O.Ms.No.33, dt.12-6-2025 issued by the 1st respondent herein, pending disposal of WP 15448 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Nalli Sunil Rao, Advocate for the Petitioner and of GP FOR IRRIGATION AND CAD for Respondent Nos.1, 3 to 5 and of GP for Revenue for Respondent No.2 and of GP for Panchayat Raj for Respondent No.6 and of Sri Y.Koteswara Rao, Standing Counsel for Respondent No.7, the Court made the following

ORDER:

"Having considered the submissions made by the learned counsel for the petitioner, there shall be an interim suspension of G.O.Ms.No.33, dated 12.06.2025.

Post the matter after four (04) weeks.

In the meantime, respondents are directed to file counter affidavit."
