Petition under Section 528 of BNSS, 2023 is filed praying that in the circumstances stated in the memorandum of grounds of criminal petition, the High Court may be pleased to stay all further proceedings under Order dated, 23.02.2026 in M.C.No.27 of 2025, passed by the Court of Family-cum-VIII Addl. District & Sessions Judge, at Ongole, Prakasam District, pending disposal of CRLP No.4867 of 2026, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

1. This application is filed under Section 528 of Bharatiya Nagarik Suraksha Sanhita, 2023 challenging the order dated 23.02.2026 passed in CrI.M.P.No.924 of 2025 in M.C.No.27 of 2025 on the file of Judge, Family Court-cum-VIII Additional District & Sessions Judge at Ongole, Prakasam District.

2. Learned counsel for the petitioner submit that respondent No.1/wife filed a petition under Section 144(1) of Bharatiya Nagarik Suraksha Sanhita, 2023, for interim maintenance which was allowed by the learned Judge, Family Court-cum-VIII Additional District & Sessions Judge at Ongole, Prakasam District, granting Rs.10,000/- to the petitioner No.1/wife and Rs.7,000/- each to the petitioner Nos.2 to 4/children per month from the date of petition on or before 10th of every succeeding month.

3. Learned counsel asserted that in view of the petitioner's age as well as his ailments, he is not able to pay such amount at this juncture. He also contends that before ordering interim maintenance he has taken care the needs of his children.

4. Having regard to the facts and circumstances of the case, there shall be an interim stay of all further proceedings pursuant to the order dated 23.02.2026 passed in Cri.M.P.No.924 of 2025 in M.C.No.27 of 2025 on the file of Judge, Family Court-cum-VIII Additional District & Sessions Judge at Ongole, Prakasam District, on condition to deposit Rs.8,000/- to the respondent No.1 and Rs.5,000/- each to the respondent Nos.2 to 4 per month from the date of petition on or before 10th of every succeeding month. Petitioner is further directed to deposit the arrears if any corresponding by calculating the above stated amount within four (04) weeks from today, failing which this order shall stand vacated automatically.
