WHEREAS the Petitioner above named through his Advocate Sri MEDIKONDA PRANAY VENKAT CHOWDARY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the inaction of the respondents in not releasing the bills amount worth of Rs. 3,96,000/- with Interest thereof for completion of the allotted work as per the agreement dated 29.11.2022 even though total work was completed as illegal, arbitrary and violation of Article 14 and 21 of constitution of India and consequently direct the respondents to forthwith release and pay the bills worth of Rs 3,96,000/- with 18% rate of interest, grant costs of the proceedings.

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of Sri MEDIKONDA PRANAY VENKAT CHOWDARY Advocate for the Petitioner and of Assistant Government Pleader for Finance and Planning for respondent No.1, and of Assistant Government Pleader for Medical, Health and Family Welfare for respondent Nos. 2 and 3 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
