Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of a Writ of Mandamus declaring the action of the Respondents, Specifically 6th respondent in trying to transfer orally without issuing any proceedings / Orders to the petitioners from their present workplaces I.e., Kasturba Gandhi Balika Vidyalaya, Chenna Kotha Palli, Chenna Kotha Palli and Bommanahal respectively Ananthapur Erstwhile District as illegal. Arbitrary, Discrimination, Violation of Principles of Natural Justice and against to violation of Articles 14 and 21 of Indian Constitution, consequently direct the respondents. Specifically 6th respondent not to transfer the Petitioners from their working places at Kasturba Gandhi Balika Vidyalaya, Chenna Kotha Palli, Chenna Kotha Palli and Bommanahal respectively Anantapur Erstwhile District

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents, Specifically 6th respondent herein not to transfer the petitioners from Kasturba Gandhi Balika Vidyalaya, Chenna Kotha Palli, Chenna Kotha Palli and Bommanahal respectively Anantapur Erstwhile District by way of considering the Representation of the petitioners sent to the 6th respondent

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri ANURADHA GURRAM Advocate for the Petitioner(s), GP FOR SCHOOL EDUCATION for the Respondent Nos. 1 to 3, SC for Samagra Siksha for respondent Nos. 4 to 6, and the Court made the following.

ORDER

This writ petition is filed questioning the action of Respondents in seeking to transfer the Petitioners orally without issuing any proceedings as illegal and arbitrary.

Learned standing counsel submits that there is no requirement of furnishing any written order to effect transfers of the Petitioners who are working as Teachers on contract basis.

This Court is of the opinion that an individual working in the Respondents - Societies as Teacher cannot be transferred without any instructions as the approach is unknown to law.

Therefore, there shall be an interim direction to the Respondents not to transfer the Petitioners except by issuing a written order.
