Petition under Section 151 CPC is filed, praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent Nos. 4 to 8 stop the illegal/Unauthorised in construction of compound wall in the land to an extent of Ac.2.48 cents in Sy.No.243/3 of Cherlopalle Village, Tirupati Rural Mandal, Tirupati District forthwith, Pending disposal of WP No. 16040 of 2026, on the file of the High Court.

The court, while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER

The learned counsel for the petitioner submitted that respondent No.3 passed the impugned order directing the police to provide protection to the respondent No.8 for construction of the compound wall without notice or hearing the petitioner and that the respondents are proceeding with the illegal construction of the compound wall and prayed to grant protection to the interest of the petitioner. He placed copies of the photos showing progress in the construction and the police present over the disputed area.

Perused the impugned order and the other documents. Merely on the representation dated 01.06.2026, the respondent No.2 passed the impugned order on 05.06.2026 directing the police to provide support to the respondent No.8 for construction of the boundary. There was no hearing or opportunity given to the writ petitioner.

Under these circumstances, the interim order as prayed for is granted till 24.06.2026.
