WHEREAS the Petitioner above named through her Advocate Sri V Sudhakar Reddy, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order, direction or writ, more particularly one in the nature of writ of Mandamus declaring the high handed action of the respondents particularly respondent Nos.3 to 6 in entering into the house site of the petitioner in L.P.No.486 (old Sy.No.25) of Pedda Jonnavalasa village, Amadalavalasa Mandal, Srikakulam District on 15.06.2026 by taking measurements to lay a CC road across the said house site from west to east without following due process of law as illegal, arbitrary, without any authority of law or jurisdiction and in clear violation of Principles of Natural Justice and also violation of Articles 14, 21 and 300-A of the Constitution of India and consequently direct the respondents not to lay a road in the house site and not to dispossess her from the house site an extent of Ac.0.0125 cents in L.P.No.486 (Old Sy.No.25) of Pedda Jonnavalasa village, Amadalavalasa Mandal, Srikakulam District.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri V Sudhakar Reddy, Advocate for the Petitioner, and of GP for Panchayat Raj & Rural Development for Respondent Nos. 1 to 5, directed issue of notice to the Respondent No.6 herein to show cause as to why this WRIT PETITION should not be admitted.

are be and hereby directed to show cause within three (03) weeks to which date the case stands posted either appearing in person or through an advocate as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to neither lay a CC road nor dispossess the petitioner from her house site in an extent of 18.5 Sq.Yds in L.P.No.486 (Old Sy.No.25) of Pedda Jonnavalasa village, Amadalavalasa Mandal, Srikakulam District, Pending disposal of WP No.16051 of 2026, on the file of the High Court.

The Court made the following: ORDER

Notice before admission.

Ms. Naga Chandrika, learned Assistant Government Pleader for Panchayat Raj and Rural Development takes notice for respondent Nos.1 to 5.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.6 through Speed Post/Registered Post with Acknowledgment Due and shall file proof of service in the Registry within a period of Three (03) weeks.

Heard. Perused the record.

It is the case of the petitioner that the Tahsildar, Amadalavalasa granted house site certificate dated 18.09.2019 to an extent of Ac.0.0125 cents (60.5 square yards). The Government sanctioned a house under PM Avasa Yojana Scheme, and accordingly, she got constructed a house building in an extent of 42 square yards and left open an extent of 18.5 square yards in backyard on the northern side for the purpose of constructing bathroom and lavatory and to keep firewood.

Learned counsel for the petitioner would contend that the respondents are high-handedly trying to lay a road in her house site i.e. backyard of her house, which was left for construction of bathroom, lavatory, and if the road is laid, the petitioner will be deprived of her valuable site and purpose for which she kept her house site vacant, will be defeated.

Learned Assistant Government Pleader for respondent Nos.1 to 5, on oral instructions, submits that there is an existing kaccha road in the said disputed site and seeks time for filing counter-affidavit.

A perusal of the material on record *prima facie* goes to show that petitioner has been granted house site to an extent of Ac.0.0125 cents. As per the contention of petitioner, the respondents are trying to lay road, which deprives the petitioner's right over 18.5 square yards, kept vacant in backyard on the northern side, for the purpose of constructing bathroom and lavatory. The matter requires examination.

In the facts and circumstances of the case, the respondents are directed to maintain *Status Quo* for a period of Three (03) weeks. In the meantime, the respondent Nos.1 to 5 are directed to file counter-affidavit.

List the matter after Three (03) weeks.

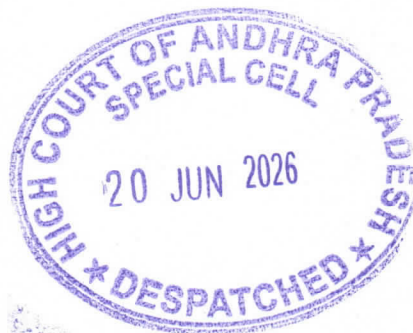
