The Court made the following Order:

Learned counsel for the petitioner submits that the petitioner is arrayed as accused No.3 in C.C.No.1488 of 2016 on the file of Special Judicial Magistrate of First Class, Mobile Court, Kurnool, for alleged offences under Sections 304-A and 202 of IPC. It is submitted that the allegation against the petitioner is that the petitioner has not informed about the death of the son of the 2nd respondent soon after his demise.

2. Learned counsel for the petitioner submits that the petitioner was working as a duty doctor, who initially admitted him in the critical care unit. It is submitted that the 2nd respondent's son fell down from ten feet height pole and suffered injury to his head which resulted in his passing away. It is submitted that the 2nd respondent had also submitted the casualty LAMA Form dated 14.03.2013 duly indicating that he does not want to inform the police about the injuries and that he has executed the said form as he was leaving against medical advice. It is submitted that the petitioner has been issued NBW for non-appearance in the Court. It is submitted that the petitioner is presently working as Consultant, physician and also diabetalogist at Hyderabad.

3. Heard learned counsel for the petitioner and learned Assistant Public Prosecutor appearing for the State.

4. Considering the nature of work of the petitioner, the learned Special Judicial Magistrate of First Class, Mobile Court, Kurnool, is directed to consider the petition for recall of warrant subject to the petitioner appearing in person before the Court and filing a petition under Section 70(2) of Cr.P.C.

On submission of the petition, the learned Magistrate shall recall the warrant on the same day and impose such other conditions for expeditious disposal of C.C.No.1488 of 2016.

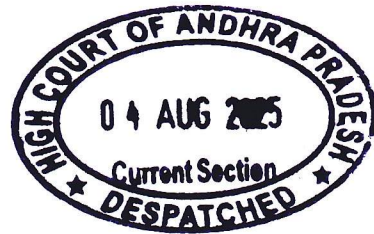
