Petition under Section 528 of BNSS (Old Provision under Section 482 of Cr.P.C), praying that in the circumstances stated in the memorandum of grounds filed in support of the petition, the High Court may be pleased to modify the order passed in CRLP No.6460/2025 dated 21.07.2025 by considering the situation of the Petitioner/Accused No.1 as^d Petitioner/A1 shall be released on bail on executing a personal bond for Rs.10,000/- with single surety for a like sum each to the satisfaction of the Hon'ble II Addl. Chief Judicial Magistrate, Visakhapatnam" instead of "Petitioner/A1 to be released on bail on executing a personal bond for Rs.25,000/- with two sureties and permit the Petitioner/Accused No.1 to deposit the surety bond amount of Rs.10,000/- with single surety instead of Rs.25,000/- with two sureties, Pending disposal of CRLP No.6460 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated 21.07.2025 made in CrI.P.No.6460 of 2025 and upon hearing the arguments of Sri Pulapalli Babji, Advocate for the Petitioner and of Public Prosecutor, for the Respondent, Court made the following.

ORDER:

“Heard the learned counsel for the petitioners and the learned Assistant Public Prosecutor.

For the reasons stated in the accompanying affidavit filed in support of the petition, the condition imposed on the petitioners/Accused Nos.1 and 2 in CrI.P.No.6460 of 2025 dated 21.07.2025 that they shall execute a personal bond for Rs.25,000/- each with two sureties for a like sum each to the satisfaction of the learned II Additional Chief Judicial Magistrate, Visakhapatnam, is hereby modified as follows:

The petitioners/Accused Nos.1 and 2 herein shall be released on their executing a personal bond for Rs.10,000/- each with one surety each for a like sum each to the satisfaction of the learned II Additional Chief Judicial Magistrate, Visakhapatnam.

Accordingly, the I.A.No.1 of 2025 is allowed.”
