COMMON ORDER:-

The issues involved in these two Writ Petitions are one and the same, and therefore, these two Writ Petitions have been heard and are being disposed of by this Common Order.

2. The W.P.No.13895 of 2013 was filed questioning the action of the Respondents in not holding elections to the Society as per Section 31 (2) (b) of the A.P. Cooperative Societies Act, 1964, in spite of the representations dated 10.03.2013 and 23.04.2013. The W.P.No.20979 of 2015 was also filed for similar relief.

3. When the matters are taken up for hearing, learned counsel for the Petitioners as well as the learned counsel for the Respondents submit that the issue raised in these Writ Petitions is squarely covered by the Order of this Court in W.P. No. 14000 2013, dated 19.02.2026, and request to pass similar order in these Writ Petitions.

4. Recording the said submissions, these Writ Petitions are disposed of in terms of W.P. No.14000 of 2013, dated 19.02.2026. There shall be no order as to costs.
