Learned counsel for the petitioners further submits that the initiation of the impugned proceedings is contrary to the settled legal principles as well as the object and intention underlying Section 164 of the Bharatiya Nyaya Suraksha Sanhita, 2023 corresponding to Section 145 of the Code of Criminal Procedure, 1973.

12. Having regard to the facts and circumstances of the case, the order dated 13.02.2026 in M.C.No.41/2026/B, passed by the Mandal

Executive Magistrate, Kadiri, is hereby suspended, pending disposal of the Criminal Revision Case."
