WHEREAS the Petitioner above named through her Advocate Sri P Narasimha Rao presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order, Writ or Direction, more particularly one in the nature of Writ of Mandamus under Article 226 of Constitution of India, by declaring that the in-action of the official respondents 1 to 4 in not taking appropriate action against the 5th and 6th respondents herein on petitioner's representations dt 20-8-2019 and 26-8-2019 by not protecting her right of easement by necessity under section 13 of Law of Easements Act 1882, failure to protect the right to enjoyment of property guaranteed under Article 21 of the Constitution, and failure to take action against the 5th respondent under Sec. 145 and 147 of CRPC etc, as illegal, unconscionable and patent failure in discharging their legitimate official duties etc, in the interest of justice and to grant any such other or further reliefs.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri P Narasimha Rao Advocate for the Petitioner, GP FOR REVENUE for the Respondent Nos. 1 to 4, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
