Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents no.4 and 5 in proceeding to conduct the survey and fix the boundaries in respect of Sy.no.172/4 an extent of Ac.2.03 cents of Chiguruvada South Kandriga, Tirupati Rural Mandal as illegal and arbitrary and without any authority and consequently direct the respondents no.4 and 5 not to proceed with the conducting the survey of the land Sy.No.172/4 and to fix the boundaries to an

extent of Ac. 2.03 cents in Sy.no.172/4 of Chiguruvada South Kandriga, Tirupati Rural Mandal.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the grounds filed in support of the petition, the High Court may be pleased to direct the respondents 4 and 5 not to interfere in possession and enjoyment of the petitioner in respect of the land an extent Ac. 0.68 cents in Sy. No. 172/4B4 of Chiguruvada South Kandriga under the guise of to conduct survey and fix the boundaries in respect of the land in Sy.No.172/4 of Chiguruvada South Kandriga, Tirupati Rural Mandal, Pending disposal of WP 16220 of 2025, on the file of the High Court.

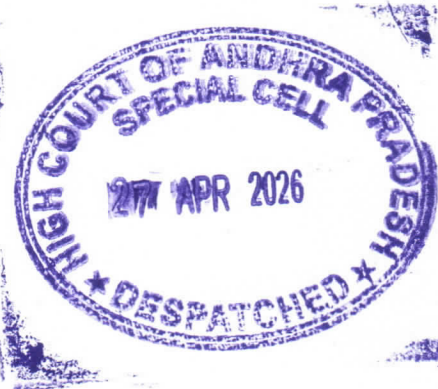
