Petition under Article 226 of the Constitution of India is filed praying that
in the circumstances stated in the affidavit filed therewith, the High Court may
be pleased to issue an appropriate Writ, order or direction more particularly
one in the nature of WRIT OF MANDAMUS declaring the action of the

respondents in not releasing the bill amounts of Rs. 7,81,915/- with interest at the rate of 24% p.a. for the execution of 5 road works as per the orders of the 5th respondent with its general funds in Amudalapalli Gram Panchayat limits, Podili Mandal, Prakasam District, is illegal, arbitrary and violation of Article 19(1)(g) of Constitution of India.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to release the bill amounts of Rs. 7,81,915/- with interest at the rate of 24 % p.a. for the execution of 5 road works as per the orders of the 5th respondent with its general funds in Amudalapalli Gram Panchayat limits, Podili Mandal, Prakasam District, Pending disposal of WP 16273 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI KOTI REDDY IDAMAKANTI Advocate for the Petitioner, GP FOR PANCHAYAT RAJ RURAL DEV for the Respondent Nos.1 & 3 , GP FOR FINACE & PLANNING for respondent No.2, and the Court made the following.

ORDER

The above writ petition was filed to declare the action of respondents in not releasing the bill amount of Rs.7,81,915/- with interest at the rate of 24% per annum for execution of five road works as per the orders of the 5th respondent with its general funds in Amudalapalli Gram Panchayat limits, Podili Mandal, Prakasam District, as illegal and arbitrary.

The writ petition was initially listed on 30.07.2024 and adjourned from time to time, either for filing of counter-affidavit or for getting

instructions. Till date, neither the counter-affidavit has been filed nor any written instructions have been placed before this Court.

Learned Assistant Government Pleader for Panchayat Raj and Rural Development seeks further time to file counter-affidavit/place written instructions.

List the matter on 18.02.2026 finally.

It is made clear that if no counter-affidavit is filed or written instructions are placed before this Court by the next date of hearing, the respondents 4 and 5 shall appear before this Court along with the entire record.
