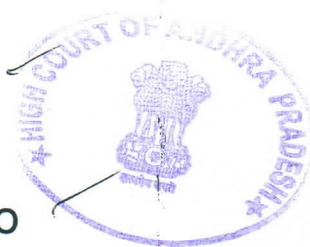

The learned counsel for the petitioners submits that the petitioners have been languishing in jail pursuant to the judgment passed by the learned Appellate Court dated 21.05.2026.

Sentence of imprisonment imposed by the learned Sessions Judge, Kurnool, *vide* order dated 21.05.2026 in CrI.A.No.24 of 2026 alone is suspended pending disposal of the Criminal Revision Case.

The petitioners herein shall be enlarged on bail on their executing a bond for a sum of Rs.50,000/- (Rupees Fifty Thousand only) each with two sureties each for the like sum each to the satisfaction of the learned Judicial Magistrate of First Class, Dhone.
