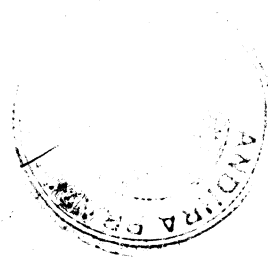

WHEREAS the Petitioner above named through his Advocate Sri Ineni Venkata Prasad presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondent No,3 refused the document for registration in so for plot No.13 an extent of 260 square yards approved L.P.No.79/1982 in survey No.340 of Kallur village and mandal, Kurnool District vide Ref,No.SRO/ Kallur/Refusal order dated 16-06-2020 Refusal No. 03 of 2020 BK-II refused as No.3 of 2020 BK-11 as the schedule Survey No.340 of Kallur village of Kallur .Mandal is Wakf land , vide CEO, AP state wakf Board. Vijayawada F.No.01/Prot/Gen1/2016, Dt.16-11-2016 as being illegal, arbitrary and violative of Article 14 and 300-A of the Constitution of India and consequently set aside the vide CEO, AP state wakf Board, Vijayawada F.No.01/prot/AP/Gen1/2016 dated 16-11-2016 and receive, process and release the document.
