Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction more particularly one in the nature of Writ of MANDAMUS declaring the impugned order bearing RC.A3 130/2023, 22-05-2023 of the 4th Respondent herein whereby canceling the pattadhar pass books pertaining to the land in R.S.No.221/1 Ac.2-67 cents of Pochampalli Village, Nandigama Mandalam, NTR Krishna District in violation of principles of natural justice and without having any Authority under the A.P. Rights in Land and Pattadhar Pass Books Act, 1971 as arbitrary, illegal, capricious and violative of fundamental rights guaranteed under Articles 14, 21 and 300-A of the Constitution of India and consequently set aside the said order.
