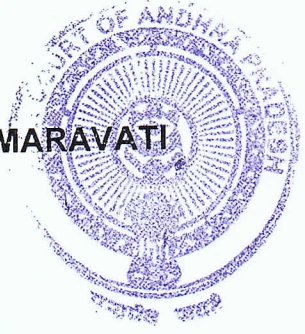

Petition under Article 226 of the Constitution of India is filed praying
that in the circumstances stated in the affidavit filed therewith, the High
Court may be pleased to issue an appropriate Writ order or direction more
particularly one in the nature of Writ of a Mandamus seeking to declare the
inaction of the Respondents in attempting to disconnect electricity service

connection bearing No.2412656000413 situated in Sy.No.747 of Dudhyala Village, Sambepalli Mandal, Annamayya District, without following due process of law. The said action is arbitrary, illegal, highhanded, and a colorable exercise of power. It is contrary to well-established legal principles and violative of the fundamental and constitutional rights guaranteed to me under Articles 14,19, 21, and 300A of the Constitution of India and consequently direct the respondents not to disconnect the electricity connection bearing No. 2412656000413 situated in Sy.No.747 of Dudhyala Village, Sambepalli Mandal, Annamayya District;

IA NO: 1 OF 2025:

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents not to disconnect the electricity connection bearing No.2412656000413 situated in Sy.No.747 of Dudhyala Village, Sambepalli Mandal, Annamayya District, pending disposal of WP.No.16754 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Papudippu Sashidar Reddy, Advocate for the Petitioner and GP for Energy for the Respondent No.1 and Sri V.V.Satish, Standing Counsel for the Respondent Nos.2 to 5, the Court made the following;

ORDER:

“Sri V.V.Satish, learned standing counsel takes notice for respondents 2 to 5, offers to file vakalat and seeks time to get instructions.

Learned counsel would submit that the Tahsildar addressed a letter to 4th respondent indicating that the petitioner dug a bore well without permission and, in fact, recommended to remove the current connection immediately.

Learned counsel for the petitioner shall produce the permission granted to the petitioner to dig the bore well.

Learned standing counsel seeks time to produce Circular or Board proceedings if any, regarding disconnection of power supply in pursuance of letter addressed by the Revenue officials.

List on 10.07.2025 in Adjourned motion List.

Till such time, the respondents 4 and 5 shall not disconnect the power connection to the bore well."
