Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction more particularly one in the nature of Writ of Mandamus to declare the action of the 7th Respondent in surrendering the Petitioner to 6th Respondent vide Proceedings in Rc.No.1 of 2022 dated 31.07.2023 and resolution dated 31.07.2023 on the pretext of not submitting leave permission from the authorities despite having sanctioned earned leave for the period 24.03.2023 to 29.07.2023 vide resolution dated 30.07.2023 and not permitting the Petitioner to undertake his duties as CEO as highly arbitrary. high-handed, vengeful, violative of principles of natural justice, violative of fundamental rights guaranteed to the Petitioner under Article 14, 19 and 21 of Constitution of India and violative of provisions of Andhra Pradesh Cooperative Societies Act, 1964 and consequently to set aside the proceedings in Rc.NO. 1/2022 dated 31.07.2023 and resolution of the 7th Respondent dated 31.07.2023 with respect to surrendering the Petitioner to the Respondent forthwith to permit him to continue his services as Chief Executive Officer, Kakumanu PACS i.e., 7th Respondent and pass
