Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of operation of Decree and Award dated 17.03.2023 passed in M.V.O.P No. 515 of 2018 on the file of Motor Accidents Claims Tribunal cum XII Addl. District Judge, Vijayawada, pending disposal of MACMA No. 374 of 2023, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

"Heard learned counsel for the appellant.

Perused the material on record.

Having regard to the facts, submissions and the issues raised for consideration in the grounds of the appeal, which require a detailed examination, there shall be an interim stay of operation of the Award dated 17.03.2023 passed in M.V.O.P.No.515 of 2018 on the file of the Chairman, Motor Accidents Claims Tribunal – cum – XII Additional District Judge, Vijayawada, subject to the condition that the appellant / the A.P.S.R.T.C. shall deposit 50%

of the entire decretal amount with proportionate interest and costs within a period of eight (08) weeks from today.

On such deposit, Smt. Chitta Venkata Dhana Lakshmi/the claimant/the 1st respondent, is permitted to withdraw 50% of compensation in terms of the decree with proportionate interest and costs by following the procedure established by law, however, without prejudice to the rights and contentions of both the parties in the appeal."
