WHEREAS the said case coming on for orders as to admission on this day and whereas the High Court, upon perusing the affidavit filed therein and the earlier orders of the High Court dated. 09.08.2024, & 26.11.2025, made herein and upon hearing the arguments of Sri ANUP KOUSHIK KARAVADI, Advocate for the Petitioner, and of SRI Y.SOMA RAJU, Advocate for the Respondent Nos.1 & 5 and of SRI VENKATA SAI KRISHNA PONNURU, Advocate for the Respondent Nos.2 to 4, and of SRI NAGARAJU PULLAGURA, Advocate for the Respondent No.7, the Court made the following ✓

ORDER:

The reply/counter-affidavit filed in contempt case, at paragraph No.3, indicates that an amount of Rs.0.57 crores has been sanctioned and is pending for release and the same will be released as per the seriatim, subject to the availability of funds.

This Court specifically posed a question to the learned counsel for respondent No.1, regarding the time frame for payment of the due amount to the petitioner. Learned counsel sought six weeks time for payment of the said amount.

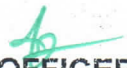
Keeping in view that the amount due to the petitioner is huge, this Court is liberally granting six weeks time for payment of Rs.0.57 crores to the petitioner.
