WHEREAS the Petitioner above named through his Advocate Sri NAVULURU KRISHNA SAI presented this Petition under Article 226 of the

Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ order or direction more particularly one in the nature of Writ of Mandamus

a) aggrieved by the action of the respondents in taking the land for public purpose to an extent of Ac. 4.22 cents in Sy.No. 498/2 situated in Pulivendula Village, Pulivendula Mandal, YSR Kadapa District without paying the legitimate compensation as per the provisions of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 is illegal, unjust and contrary to the provisions of Act 30 of 2013, Violative of Article 300-A of the Constitution of India and consequently direct the respondents to initiate land acquisition proceedings as per the provisions of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 by duly paying the compensation to the petitioner to an extent of Ac. 4.22 cents in Sy.No. 498/2 situated in Pulivendula Village, Pulivendula Mandal, YSR Kadapa District,

b) To set aside the endorsements issued by the 3rd and 4th respondents dated 28.10.2024;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri NAVULURU KRISHNA SAI Advocate for the Petitioner, and of GP for Revenue (Land Acquisition), Department for R1 to R4 directed issue of notice to the Respondents No.6 and 7 herein to show cause as to why this WRIT PETITION should not be admitted.
