procurement tender notice dated 10.06.2026, is being bad, illegal, arbitrary, contrary to tender conditions, discriminatory and offends Article 14 and 19 of Constitution of India and consequentially to direct the 2nd respondent to open the Financial bid of the petitioner, submitted on 22.06.2026 and to award work order, if found the petitioner to be successful bidder being LI in the said tender process interest of justice.
