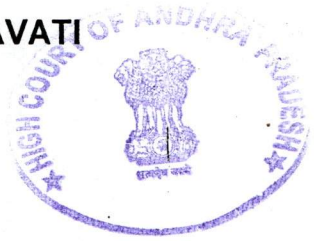

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly, one in the nature of Writ of Mandamus, declaring the action of the respondents no. 1 to 4 in not taking action for appointing the Executive Officer to the 6th respondent institution and protecting the valuable immovable properties belonging to the 6th respondent institution admeasuring Ac. 20.81 cents in Sy.No.516/2A, 516/2B, 516/3, 516/1 situated at Dargamitta, Nellore, SPSR Nellore District and also the high handed action of the 7th respondent in trying to dispossess the writ petitioner from land admeasuring Ac. 4.00 cents situated in Sy.No.516/2A at Dargamitta, Nellore, SPSR Nellore District and also proposing to demolish the existing structures as bad, illegal, arbitrary, without jurisdiction and violative of Articles 14, 21 and 25 of Constitution of India and consequently direct the respondents no.1 to 4 to appoint the Executive Officer to the 6th respondent institution and also protect the valuable immovable properties belonging to the 6th respondent institution admeasuring Ac. 20.81 cents in Sy.No.516/2A, 516/2B, 516/3, 516/1 situated at Dargamitta, Nellore, SPSR Nellore District and not to interfere and demolish the structures made by the petitioners land admeasuring Ac.4.00 cents situated in Sy.No.516/2A at Dargamitta, Nellore, SPSR Nellore District

IA NO: 1 OF 2026

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to not to interfere with the peaceful possession and enjoyment of the petitioners from the land admeasuring Ac. 4.00 cents situated in Sy.No.516/2A at Dargamitta, Nellore, SPSR Nellore and not to demolish the structures therein without following due process of law, Pending disposal of WP No.18360 of 2026, on the file of the High Court.

IA NO: 2 OF 2026

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents no. 1 to 4 to consider the petitioners representation dated 11.06.2026 for taking steps for appointment of the Executive Officer to the 6th respondent institution and also for protecting the valuable immovable properties belonging to the 6th respondent institution, Pending disposal of WP No.18360 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri D V Sasidhar, Advocate for the Petitioner, and of GP for Endowments for the Respondent Nos. 1 to 4, and of GP for Revenue for Respondent No.5, and the Court made the following.

ORDER

Disputed questions of fact are involved. However, the petitioner is seeking protection from this Court against dispossession from the property admeasuring Ac.4.00 cents in Sy.No.516/2A at Dargamitta, Nellore, SPSR Nellore.

Sri Venu Gopala Rao, learned Senior Counsel appearing on behalf of the petitioner, requested this Court to direct the 2nd respondent, before whom representation dated 11.06.2026 is pending, to examine the said representation and pass appropriate orders in accordance with law.

Acceding to the said request, the 2nd respondent is directed to examine the representation dated 11.06.2026 and pass appropriate orders in accordance with law within a period of three weeks and

communicate the decision to the petitioner. Till such time respondents are directed to maintain *Status Quo* as on today.
