WHEREAS the Petitioners above named through their Advocate M/s.MALLAVOLU NIKITHA, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus to:

- i) Declare that the action of the 3rd respondent in proceeding to recover the amount by issuing notice under Sec. 13(9) of the Act read with Rule 8(6) of the Rules framed therein under the provisions of Securitization and Reconstruction of Financial Assets and Enforcement of Security interest Act and rules framed there-under is illegal, arbitrary and without jurisdiction;
- ii) Set aside the Notice dated 11-05-2026 issued under Sec. 13(9) of the Act read with Rule 8(6) of the Rules framed therein under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest of India Act, 2002, as illegal, arbitrary and violation of Constitutional right guaranteed under Article 300-A of Constitution of India besides violation of my right to life and liberty guaranteed under Article 21 of the Constitution of India, so also contrary to the principles laid down in Mathew Varghese vs. M Amritha Kumar (2014) 5 SCC 610 Case;
- iii) Direct the 3rd respondent to proceed and recover the amount by filing appropriate proceedings in a competent civil Court in view of the clear dispute as to illegal withdrawal/transfer of amount from petitioners account to the account of 2nd respondent;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/s. MALLAVOLU NIKITHA Advocate for the Petitioners, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
