According, there shall be interim direction to respondent Nos.4 and 5 to consider the application of the petitioner for issuance of Title deed Passbook and Pattadar Passbook after conducting necessary enquiry in accordance with law, within a period six (6) weeks from the date of receipt of copy of this order."

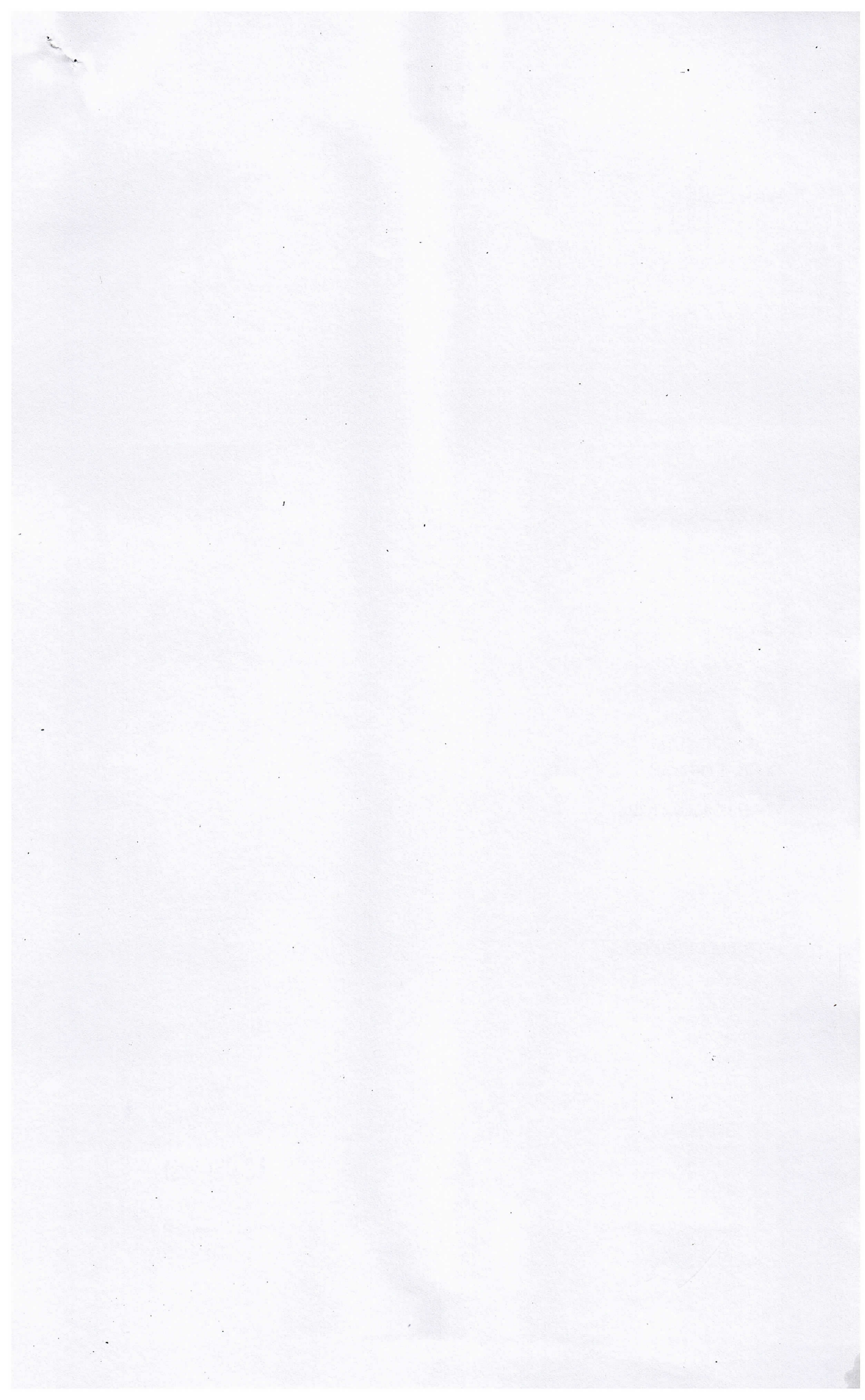
