The Petition coming on for hearing upon perusing the petition and grounds filed in the revision and upon hearing the arguments of Sri V.V.Varada Rajulu, Advocate for the Petitioner and of the Public Prosecutor for the Respondent No.3, the Court made the following

ORDER:

" Heard.

Considering the submissions made by the learned counsel for the petitioner, there shall be interim suspension of order dated 20-10-2020 passed in MC.No. 290 of 2017 on the file of Judge Principal Family Court-cum-IV Additional District Judge, Vijayawada pending revision, subject to petitioner depositing the total arrears of maintenance amount of Rs. 11,60,000/- (Rupees eleven lakhs sixty thousand only) calculated upto November, 2020 in four monthly installments at the rate of Rs. 2,90,000/- (Rupees two lakhs ninety thousand only) each commencing from January, 2021 and shall continue to deposit an amount of Rs. 10,000/- (Rupees ten thousand only) per month towards future maintenance of the respondents 1 and 2 herein until further orders subject to outcome of the revision."
