Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Certiorari, calling for records pertaining to Order vide F.No.AIIMS/MG/Registrar/2025- 26/MISC/ARC/86 dated 01/07/2025 passed by Respondent No.3 and quash the same after declaring and declare them as illegal, arbitrary, violation of Principles of Natural Justice and violation of Articles 14 and 21 of the Constitution of India and consequently direct the Official Respondents to permit the Petitioners to pursue their respective MBBS courses in Respondent Nos.2 and 3 institutions.

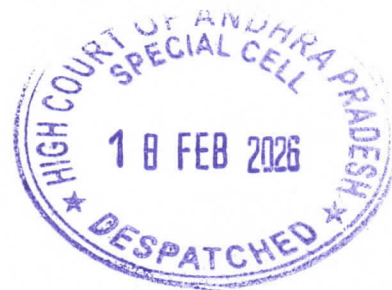
