WHEREAS the Petitioner has presented under Sections 10 to 12 of the Contempt of Courts Act 1971, above case through his counsel Sri P.V.Ramana, praying the High Court to punish the Respondents for deliberately and intentionally not implementing the order in I.A.No.1 & 2 of 2025 in W.P.No.11222 of 2025 dated 05.05.2025;

WHEREAS the said case coming on for hearing on this day and whereas the High Court upon perusing the affidavit filed herein and the order of High Court dated 18.07.2025 made herein and upon hearing the arguments of Sri P.V.Ramana, Advocate for the Petitioner, Court made the following

ORDER:

“Notices were issued to respondent Nos. 1 & 2 on 18.07.2025, as per office report notices are served, however none appears for them.

The present contempt arises out of alleged violation of interim orders dated 05.05.2025 passed in I.A. Nos. 1 & 2 of 2025 in W.P.No.11222 of 2025.

By aforesaid order, Writ Court while suspending the impugned proceedings dated 14.09.2024, issued by respondent No.2, has further directed respondent Nos.1 & 2 to consider the case of the petitioner for promotion to the post of Assistant Conservator of Forest, if he otherwise eligible and qualified. As no disciplinary proceedings are pending against the petitioner, he claims for promotion as Assistant Conservator of Forest for the panel year 2023-24. Petitioner also submitted representation dated 14.05.2025 to respondent No.2 for requesting for consideration of promotion for the panel year 2023-24, which has not been acted upon so far.

As there is no response from both the respondents and having satisfied that the interim order passed by this Court has not been complied with so far, Registry is directed to issue Form-1 to the respondents.
