Sentence of imprisonment imposed by the learned XIII Additional District and Sessions Judge, Guntur District at Narasaraopet, vide order dated 03.07.2026 in CrI.A.No.138 of 2021 alone is suspended pending disposal of the Criminal Revision Case.

The petitioner herein shall be enlarged on bail on his executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties for the like sum each to the satisfaction of the learned Additional Civil Judge (Junior Division), Chilakaluripet.”
