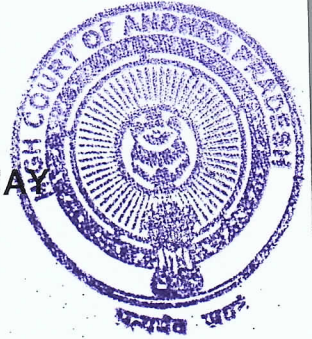

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ, Order or Orders, Direction or Directions to declare the action of the 2nd respondent in issuing the Circular.Memo.No.GAD01-SU0MISC/31/2019-SU-I, Dt. 21.07.2020 in violation to the Judgement of the Hon'ble Supreme court in S.L.P.(Civil) No. 10349 of 2018, Dt 20.03.2018 and the division bench of the this Hon'ble court in W.A.No. 318 of 2016 and batch Dt 11.11.2016 in surrendering the Network Arogya Mitras to the 5th Respondent Andhra Pradesh Corporation as illegal, arbitrary unconstitutional and to issue consequential direction to the respondents to continue the petitioners, as the employees of the 4th respondent Dr. N.T.R.Vaidya Seva Trust as Network Arogya Mithras in their respective posts and consequently direct the respondents to regularize the services of the petitioners in their respective posts and also direct the respondents to pay minimum wages by fixing the cadre as per the Judgement in State of Pujab and Others Vs Jagjith Singh and Others 2017 (1) SCC 148 passed by the Hon'ble Supreme court and also direct the Respondents to apply all the Governmental Schemes on par with the other Contract Employees .

IA NO: 2 OF 2025

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents direct the respondent to pay minimum wages by fixing the cadre as per the Judgment in State of Punjab and others Vs Jagjith Singh and others 2017 (1) SCC 148 passed by the Honble Supreme Court, Pending disposal of WP 18076 of 2025, on the file of the High Court.

IA NO: 3 OF 2025

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to apply all the Governmental Schemes on par with the other Contract Employees, Pending disposal of WP 18076 of 2025, on the file of the High Court.

IA NO: 1 OF 2025

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to surrender the petitioners to any private employment Agencies by continuing them as the employees of the 4th respondent Dr. N.T.R.Vaidya Seva Trust as Network Arogya Mithras in their respective posts, Pending disposal of WP 18076 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri GORLE GOPALAKRISHNA Advocate for the Petitioners and of GP FOR MEDICAL AND HEALTH for the Respondent Nos. 1 and 2, GP FOR FINANCE for Respondent No.3, Sri K BHASKARA RAO, Standing Counsel for Respondent No.5, the Court made the following.

ORDER

“The present Writ Petition is filed questioning the Circular Memo No. GAD01-SU0MISC/31/2019-SU-1, dated 21.07.2020 in surrendering the Network Arogya Mitras to the Respondent No.5 as the same is contrary to the Judgment of Hon’ble Supreme Court in SLP (Civil) No.10349 of 2018, dated 20.03.2018 and the Division Bench of this Court in W.A.No.318 of 2016 and batch dated 11.11.2016 as illegal and arbitrary.

A health scheme titled as “*Rajiv Arogya Insurance Scheme*” was introduced by the erstwhile Government for the State of Andhra Pradesh with effect from 01.04.2007 for providing quality health care to the family

falling below poverty line. The Petitioners were recruited for the said purpose by Respondent No.4, which is a trust created to manage the scheme.

The appointment of the Petitioners was said to be through District Level Committee, headed by District Collector. While so, G.O.Ms.No.127, dated 27.09.2014 issued renaming the health scheme as "Dr. Nandamuri Taraka Rama Rao Arogya Seva". Thereafter, G.O.Rt.No.28, dated 20.01.2016 was issued prescribing certain additional qualifications for continuing as "Vaidya Mitra". This additional prescription was questioned by the Petitioners in W.P.No.2176 of 2016 and batch and the same was dismissed. On dismissal of the same, the Petitioners have filed W.A.No.318 of 2016 and batch and the same was allowed vide Judgment dated 11.11.2016.

The Judgment and in Writ Appeal was confirmed by the Hon'ble Supreme Court in SLP (Civil) No.10349 of 2018, dated 20.03.2018. In the interregnum, the impugned order was issued transferring the services of the Petitioners to APCOS i.e Outsourcing Corporation incorporated by the State.

However, the grievance to file the present Writ Petition is that the Petitioners are being transferred from Respondent No.4 to private Outsourcing Agencies and the same is in contravention of Judgment of this Court in W.A.No.318 of 2016 and Batch and the same was confirmed by Hon'ble Supreme Court.

Learned Standing Counsel for the Respondent No.4 would contend that the impugned proceedings, vide order dated 21.07.2020, was issued and some time may be provided to the Respondents to file Counter-Affidavit.

Learned Assistant Government Pleader for Services takes notice for the Respondents 1 to 3.

Heard the respective counsel.

The operation portion in the Writ Appeal in Paragraph 51 of the Judgment in W.A.1235 of 2016, dated 11.11.2016 reads as:

"51. On the analysis as above, we are of the opinion that the appellants are entitled to be continued as Aarogya Mitras with temporary status so long as the posts against which they are engaged remain within the sanctioned strength in terms of Clause III of G.O.Rt.No.4271, Finance (SMPC) Department, dt.01.11.2008 and process for filling up the posts on permanent basis is not initiated. The appellants are also entitled to receive the remuneration as revised from time to time under the extant G.Os issued by the State for outsourced employees or the resolutions that may be passed by the Trust. If any of the appellants are found committing any misconduct or their services are found not satisfactory, the Trust shall be free to proceed against them by following the principles of natural justice. This judgment does not however preclude the Trust from creating additional posts and engaging personnel with higher qualifications to guide the appellants in rendering proper service to the beneficiaries under the scheme, nor it restrains the State and the Trust from engaging personnel with higher qualifications as Vaidya Mitras, if they so choose, as envisaged under the impugned G.O. without disturbing the appellants."

As per Hon'ble Division Bench of composite High Court of Andhra Pradesh, the Petitioners are entitled to be continued as "Arogya Mitras", as against the posts, which they were engaged, remained within the sanctioned strength. However, contrary to the same, the services of the Petitioners were transferred to Respondent No.4 corporation and the designations of the Petitioners were changed from temporary status to that of outsourcing employee, is contrary to the directions of this Court.

Therefore, notwithstanding the delay in challenge in filing the present Writ Petition, this Court is inclined to pass the following interim direction:

- (i) The impugned Proceedings dated 21.07.2020 transferring the Petitioners to Respondent No.4 shall stand suspended to the extent of Petitioners only for a period of eight (08) weeks.
