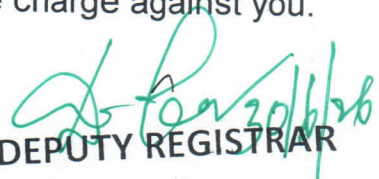
Therefore, you, viz ;
