ORDER:

1. The present application is filed to recall the warrant of arrest of Defendant-Vessel, dated 17.07.2026 issued in C.O.M.S.No. 12 of 2026.

2. Pursuant to the orders, dated 17.07.2026 passed by this Court in I.A.No.01 of 2026 in C.O.M.S.No.12 of 2026, the Petitioner/Defendant deposited an amount of Rs.61,05,446.78/-, which is equivalent to U.S Dollars 63,979.37 to the account of Registrar (Judicial), High Court of Andhra Pradesh, Amaravati.

3. As the order of the arrest of the Petitioner/Vessel itself is a conditional order to deposit U.S Dollars 63,979.37 before the Registrar (Judicial) of High Court of Andhra Pradesh within 48 hours from the date of service of notice as security to the Maritime claim of the Plaintiff.

4.
