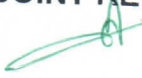
By order dated 27.04.2016, the combined High Court granted bail to the appellant; thereafter, the appellant never appeared.

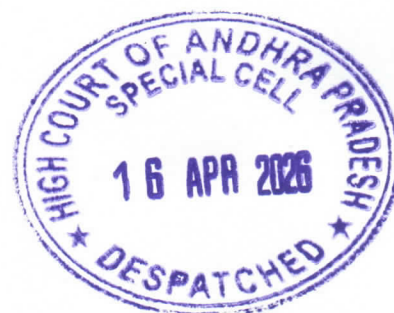

You are also directed to return this warrant as early as possible preferably on or before **29.04.2026** to this Court with a detailed report stating the manner in which it has been executed.

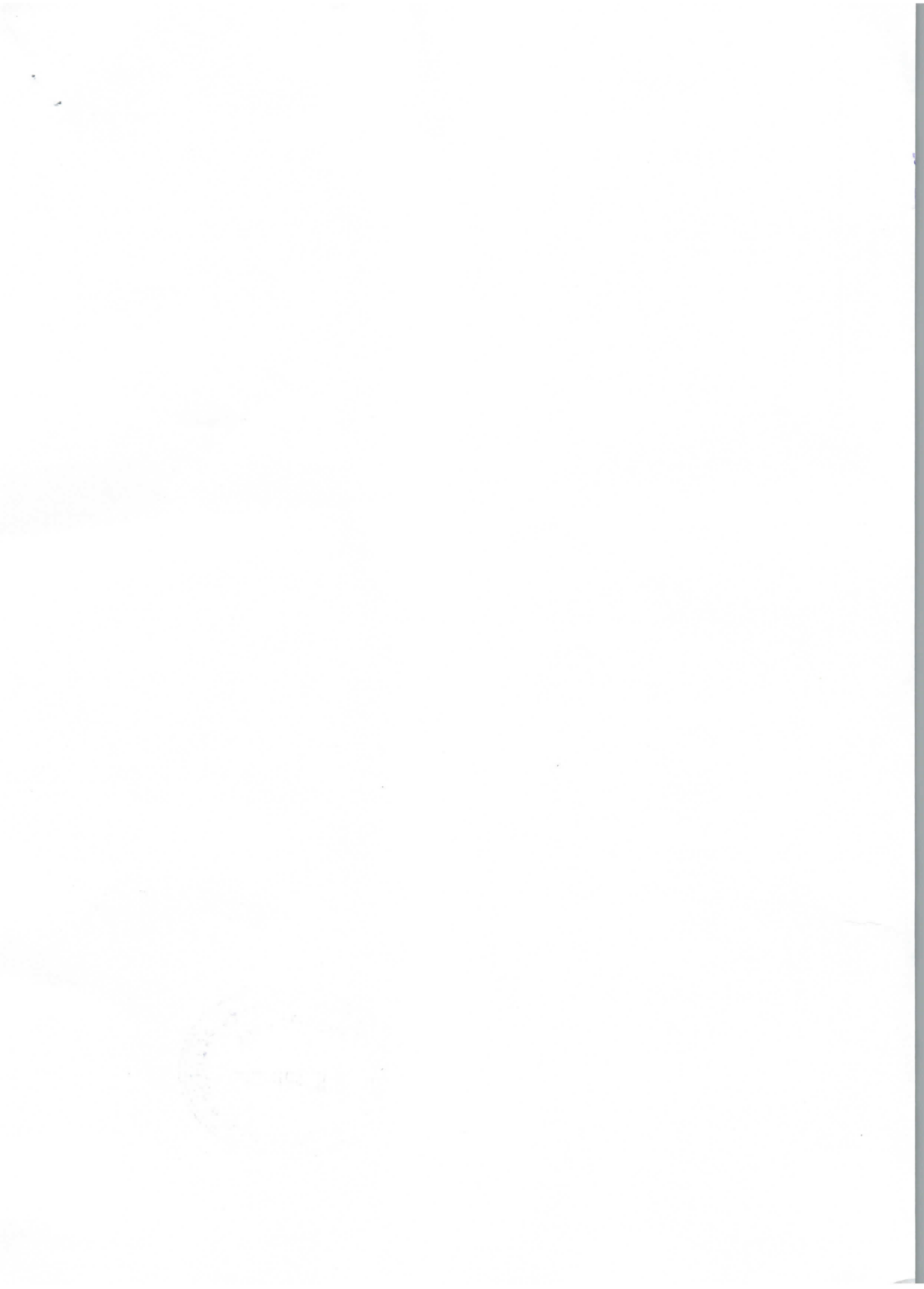
