The Criminal Petition has been filed under Section 482 of the Code of Criminal Procedure, 1973 (for brevity 'the Cr.P.C.)/Section 528 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (for brevity 'the BNSS') seeking to quash the proceedings against the Petitioners/Accused Nos.2, 3 & 5 in Crime No.190 of 2020 of C.Belagal Police Station, Kurnool District, registered for the alleged offences punishable under Section 384 read with 34 of the Indian Penal Code, 1860 (for brevity 'the IPC').

2. Heard learned counsel for Petitioners, learned Assistant Public Prosecutor and learned counsel for Respondent No.2. Perused the record.
3. On perusal of the record, the Petitioners are Accused Nos. 2, 3, and 5. A learned Single Judge of this Court, in CrI.P.No.5701 of 2020, dated 22.07.2024, quashed the proceedings against Accused Nos.1 and 4 in the above-mentioned crime. The learned Assistant Public Prosecutor, on written instructions, submits that the case in Cr.No.190 of 2020 was referred as 'Action Drop'.
4. In view of the said action drop, the Criminal Petition is disposed of.

As a sequel, Miscellaneous petitions, if any pending, shall stand closed.
