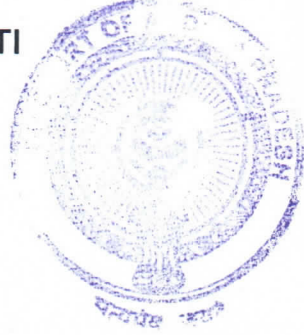

Revision filed under Sections 397 and 401 of Cr.P.C praying that in the circumstances stated in the memorandum of grounds filed in support of the Criminal Revision Case, the High Court may be pleased to allow the CrI.R.C. and set aside the judgment dated 20.08.2015, in CrI.A.No.306 of 2015 on the file of the XI Additional District and Sessions Judge, Tenali, Guntur District, insofar as convicting and sentencing the petitioners/A1 and A2 to undergo simple imprisonment for one year for the offence under Section 420 of IPC, by modifying the judgment of conviction and sentence of two years simple imprisonment passed against them in C.C.No.222 of 2015 dated 25.06.2015 on the file of the I Additional Judicial Magistrate of First Class, Tenali, Guntur District.

Petition under Section 397(1) of Cr.P.C praying that in the circumstances stated in the memorandum of grounds filed in support of the petition, the High Court may be pleased to release the petitioners/A1 & A2 on bail by suspending the operation and effect of the judgment dated 20.08.2015, in Crl.A.No.306 of 2015 on the file of the XI Additional District and Sessions Judge, Tenali, Guntur District, in so far as convicting and sentencing the petitioners/A1 and A2 to undergo simple imprisonment for one year for the offence under Section 420 of IPC, Pending disposal of CRLRC 1998 of 2015, on the file of the High Court.

The revision case coming on for hearing, upon perusing the revision and the memorandum of grounds filed in support thereof and the earlier order of the High Court dated 15.09.2015, made in Crl.R.C.M.P.No.3133 of 2015, and upon hearing the arguments of SRI N.SRIHARI, Advocate for the Petitioners, the Court made the following

ORDER:

Learned counsel appearing on behalf of the Petitioners submits that he had no contacts with his clients, being accused Nos. 1 and 2, who belong to State of Bihar.

Considering the situation, issue Bailable Warrants against the present Petitioners. The present Petitioners shall execute a bond of Rs.10,000/- with one surety before the appropriate Court by furnishing proper undertaking to appear before this Court on the adjourned date.

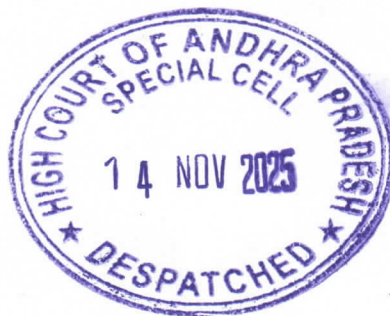

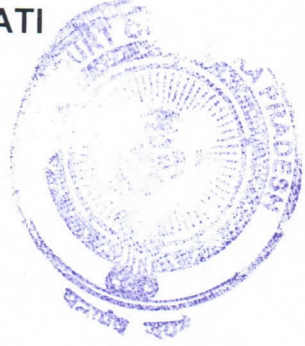

Therefore you viz;

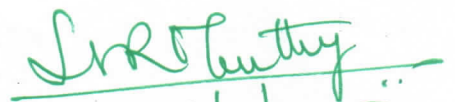
The Superintendent of Police, Guntur, Guntur District.
