

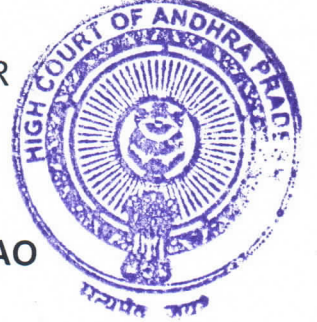

WHEREAS the Petitioner above named through their Advocate SRI V V N NARASIMHAM presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly, one in the nature of WRIT OF MANDAMUS declaring the order of 2nd respondent in proceedings in Rc.No. C1/13026(49)/1/2023, dated 23.08.2024, where- under, the order of 2nd Respondent dated 02.08.2023 held to be good which directed the Executive Officer of the 5th Respondent Temple to initiate action against the 3rd Petitioner and recover the possession of Archaka Service Inam Lands to an extent of Ac 24.00 cents in Survey No, 482 of Bukkarayasamudram Village and Mandal, Ananthapuramu District and to entrust the duty of Archakatvam service to other Archakas, besides directing the 5th respondent to make amendments under section 43(10) of Act 13 of 1987 deleting the names of petitioners no 1 and 2 as members of Hereditary Archaka Family being bad, illegal, arbitrary, discriminatory, violative of principles of natural justice, contrary to provisions of A.P. Charitable and Hindu Religious Institutions Endowments Act, 1987 and offends Articles 14, 21 and 300A Constitution of

India and consequentially to set aside the same and to direct to continue the existing system of rotation consisting of 3 families instead of 2 families.

— AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri V.Venugopala Rao learned Senior Counsel appears on behalf of Sri V V N NARASIMHAM Advocate for the Petitioners, GP FOR ENDOWMENTS for respondent nos.1 to 4, Sri G.Ramana Rao Standing counsel for respondent no.5, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
