Petition under Article 226 of the Constitution of India is filed, praying that
in the circumstances stated in the affidavit filed therewith, the High Court may
be pleased to issue an appropriate Writ, Order or Direction, more particularly
one in the nature of a Writ of Mandamus a) Declaring the Assessment Order
in FORM GST DRC-07 dated 24.04.2026 bearing DIN3724042640590 and
Reference No. Z03704260327900 passed by the 1st Respondent under
Section 74 of the Andhra Pradesh Goods and Services Tax Act 2017 for the
Financial Year 2019- 20, the Show Cause Notice in FORM GST DRC-01 d 26
bearing DIN3707022695348 and Reference No. ZD3702260080103, and the
Intimation in FORM GST DRC-01A dated 30.01.2026 bearing
DIN3730012666630 and Reference No. ZD370126031192S, to be barred by

limitation, without jurisdiction, contrary to Sections 73, 74 and 75 of the said Act, in violation of the principles of natural justice and violative of Articles 14, 19(1)(g), 265 and 300-A of the Constitution of India b) Consequently set aside the Assessment Order in FORM GST DRC-07 dated 24.04.2026 bearing DIN3724042640590 and Reference No. ZD370426032790D, the Show Cause Notice in FORM GST DRC-01 dated 07.02.2026 bearing DIN3707022695348 and Reference No. ZD3702260080103, and the Intimation in FORM GST DRC-01A dated 30.01.2026 bearing DIN3730012666630 and Reference No. ZD370126031192S, in their entirety c) Declare that no proceedings for the Financial Year 2019-20 could have been initiated or continued against the Petitioner under Section 74 of the Andhra Pradesh Goods and Services Tax Act, 2017, and that any proceedings under Section 73 for the said year stood barred by limitation.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the operation of the Assessment Order in FORM GST DRC-07 dated 24.04.2026 bearing DIN3724042640590 and Reference No. ZD370426032790D passed by the 1st Respondent for the Financial Year 2019- 20, and to restrain the Respondents from taking any coercive or recovery steps of any nature, including attachment of the bank accounts or property of the Petitioner, in pursuance thereof, pending disposal of WRIT PETITION 23685 of 2026, on the file of the High Court.

The Petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI MEDAPATI SANTOSH REDDY, Counsel for the Petitioner, GP FOR COMMERCIAL TAX, for the Respondent Nos.1 & 2, the Court made the following.

ORDER:

Considering the submission that interim orders were granted in respect of the same writ petitioner in W.P.No.3052 of 2025, list on 02.09.2026 along with W.P.No.3052 of 2025.

In the meanwhile, no coercive action pursuant to the impugned proceedings, shall be resorted to.
