

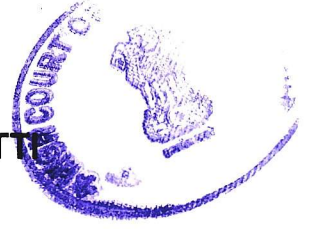

Petition under Section 115 of C.P.C, praying that in the circumstances stated in the grounds filed herein, the High Court may be pleased to allow the Revision by setting-aside the Orders dt. 18-07- 2025 of the Court of Principal Civil Judge (Junior Division)- cum- Magistrate of the First Class, Ramachandrapuram, East Godavari District, passed in E.A.No.88 of 2025 in E.P.No.6 of 2024 in O.S.No.73 of 2022, thereby allowing the Revision, by calling for the records of the E.P.No.6 of 2024 in O.S.No.73 of 2022;

Petition under Section 151 CPC, is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to Grant Interim Stay of all further Proceedings of E.P.No.6 of 2024 in O.S.No.73 of 2022 on the file of the Court of the Principal Civil Judge (Junior Division)-cum- Magistrate of the First Class, Ramachandrapuram, East Godavari District, until further orders of this Hon'ble Court, Pending disposal of CRP 1944 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the earlier orders of the High Court dated: 07.08.2025, 05.12.2025, 08.01.2026, 30.01.2026, 20.02.2026, 09.03.2026, 24.03.2026, 22.04.2026 & 03.07.2026 made herein and upon hearing the arguments of Sri P RAJESH BABU, Advocate for the Petitioner and of Sri T.B.L. MURTHY, Advocate for the Respondent No.1 and of Sri CHALLA AJAY KUMAR, Advocate for the Respondent No.2, the Court made the following;

ORDER:

Heard Sri P.Rajesh Babu, learned counsel for the revision petitioner/2nd judgment debtor, Sri T.B.L.Murthy, learned counsel for the

1st petitioner, and Sri Pavan Kumar, learned counsel representing Sri Challa Ajay Kumar, learned counsel for the 2nd respondent.

The above revision was filed assailing the order dated 18.07.2025 in E.A.No.88 of 2025 in E.P.No.6 of 2024 in O.S.No.73 of 2022 on the file of the Principal Civil Judge (Junior Division), Ramachandrapuram.

The 1st respondent, being the plaintiff, filed O.S.No.73 of 2022 against the revision petitioner/2nd judgment debtor and others for recovery of amount. The suit was decreed on 14.08.2023. Thereafter, the decree holder filed E.P.No.6 of 2024 under Order XXI Rules 54 and 64 to 66 C.P.C. for execution of the decree. The Executing Court conducted the auction on 13.12.2024, in which the 2nd respondent participated and emerged as the successful bidder.

Before confirmation of the auction, the revision petitioner/2nd judgment debtor filed E.A.No.88 of 2025 under Order XXI Rule 89(1) C.P.C. seeking to set aside the sale dated 13.12.2024 by expressing his intention to deposit the decretal amount. The Executing Court dismissed the application.

Today, when the matter is taken up for consideration, Sri Sri P.Rajesh Babu, learned counsel for the revision petitioner/2nd judgment debtor, would submit that the revision petitioner/2nd judgment debtor is willing to deposit the balance decretal amount of Rs.1,10,638/- as per the calculation memo filed by the decree holder. He also would submit that the revision petitioner/2nd judgment debtor is also willing to deposit the poundage fee of Rs.13,995/- to the credit of E.P.

The learned Executing Court shall issue the challan to the revision petitioner/2nd judgment debtor enabling him to deposit the poundage fee forthwith.

Learned counsel for the revision petitioner/2nd judgment debtor would submit that the revision petitioner/2nd judgment debtor will obtain

a demand draft with regard to the amount mentioned in the calculation memo filed by the decree holder.
