The Court made the following ORDER:

The petitioner filed O.A.No.1941 of 2017, on the file of the Andhra Pradesh Administrative Tribunal at Hyderabad, impugning the proceedings *vide* Rc.No.1229/2017/B5, dated 26.05.2017, issued by the District Collector, Guntur District, rejecting the case of the petitioner to employ on compassionate grounds, as illegal and arbitrary.

2. After the abolition of the Tribunal, the O.A., was transferred and numbered as W.P.(A.T).No.923 of 2021. The writ petition was listed on 06.02.2026; however, no representation was made on behalf of the petitioner. Hence, the matter was directed to be listed today under the caption 'for dismissal'.

3. Despite the matter being listed today under the caption 'for dismissal', there is no representation for the petitioner.

4. Sri R.S. Manidhar Pingali, learned Assistant Government Pleader, would submit that pending the writ petition (A.T.), the petitioner was employed on compassionate grounds on 25.06.2022 *vide* proceedings in Rc.No.706/2022/Admn-B3, dated 25.06.2022. The same is recorded.

5. Since there is no representation for the petitioner, as indicated supra, the petitioner is not showing interest in prosecuting the writ petition; this Writ Petition (AT) is dismissed for non-prosecution. No costs.

Miscellaneous petitions pending, if any, shall stand closed.
