The Court made the following order:

The petitioner originally filed O.A.No.2119 of 2017 on the file of learned Andhra Pradesh Administrative Tribunal, at Hyderabad (for short 'the Tribunal') to declare the action of the respondents in not promoting the petitioner as Senior Assistant form the date of promotion of his immediate junior, as illegal and arbitrary.

2. After the abolition of the Tribunal, the O.A. was transferred to High Court and the same is numbered as W.P.(APAT).No.941 of 2021

3. The writ petition was listed on 13.01.2026, however, there was no representation on behalf of the petitioner. The writ petition was directed to be listed on 13.02.2026, under the caption "for dismissal". Even on 13.02.2026, there was no representation for the petitioner. To give one more opportunity, the writ petition was adjourned to today.

4. Even today, there is no representation for the petitioner. It seems the petitioner is not interested in prosecuting the writ petition.

5. Hence, this Writ Petition is dismissed for non-prosecution. No costs.
