2. These Writ Petitions are filed questioning the inaction of Respondents in revising the final seniority list in the cadre of Agricultural Extension Officer (AEO) in Zone II, III, and IV.

3. Learned Government Pleader for ServicesIII submitted that the proposed action was pursuant to the Judgment of the Division Bench of this Court in W.P.No.1648 of 2019 and the orders passed by the coordinate benches of this Court in W.P.No.5186 of 2024 and batch, W.P.No.25660 of 2020.

4. Learned Government Pleader further submitted that, for a short period, no further action will be taken on the impugned provisional seniority list.

5. As there are issues, which require a detailed hearing, this court is of the opinion that, status quo as on date should be granted for limited period.

6. Respondents shall maintain status quo with regard to the finalization of seniority list for the post of Agricultural Extension Officer (AEO) in Zone II, III, and IV for a period of two weeks.

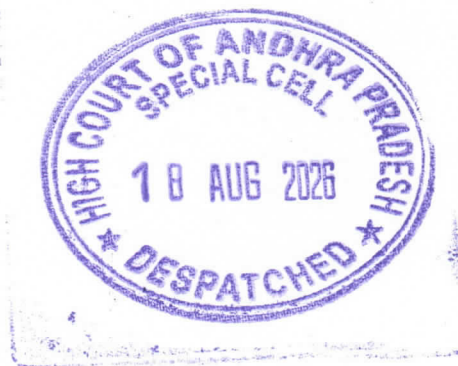
